4.	Where did Jesus tell His disciples to wait? And for what were they supposed to be waiting?

6.	Where did Jesus say the apostles would be His witnesses?
7.	After Jesus was lifted up and a cloud received Him out of their sight, what promise did the two men in white clothing give the apostles?
8.	When Peter stands up in the midst of the brethren to speak, about how many people were present?
9.	Why did Peter decide that Judas should be replaced?
10.	What qualifications did Peter give for a potential replacement apostle who could take Judas' place?
11.	Ultimately, who chose Judas' replacement?

- 6. What are "the last days" according to Peter and the prophet Joel? (see Acts 2:17)
- 7. Although it would still be some time before the apostles would preach the Gospel to anyone other than the Jews, Peter actually already proclaimed that salvation was for everyone in which verse of Acts chapter 2?
- 8. Peter says that when God raised Jesus from the dead, He actually put an end to what?
- 9. How do we know that the fulfillment of David's prophecy (Acts 2:25-28) was not speaking of David? And, of whom was this prophecy speaking?
- 10. How did Peter's message affect those who heard? What was their response?
- 11. What did Peter tell them to do to get right with God because of their sins?
- 12. How do we know that they believed the Gospel before they repented and were baptized?

- 5. Ultimately, what happened to Sapphira because of her willing participation in attempting to deceive the Holy Spirit?
- 6. Is there any good reason that we should not fear God today? Why?
